COMPANY OVERVIEW

Adams Healthcare and Staffing LLC is a home health care and medical staffing company serving Massachusetts, Rhode Island, and New Hampshire. With four years in operation, the company fields a workforce of 80 healthcare professionals delivering skilled and non-skilled care in the home, supplying clinical and support staff to facilities, and coordinating patient transportation. Its model is built around caregiver availability, giving buyers the flexibility to cover routine, specialized, and short-notice assignments.

CORE COMPETENCIES

- **Skilled home health care.** In-home clinical care delivered by nurses and certified aides, including private-duty nursing, post-acute recovery, and chronic-condition support under physician-directed care plans.
- **Non-skilled personal care and home support.** Home health aides and personal care attendants for activities of daily living, companion care, and respite for senior and disabled clients.
- **Facility and contract medical staffing.** Per diem, contract, and long-term placement of clinical and support personnel to close shift-coverage gaps at facilities and agencies.
- **Non-emergency medical transportation.** Scheduled transport to appointments, treatment, and discharge, coordinated with each client's care schedule.
- **Care coordination and continuity.** Intake, scheduling, and case oversight that keep coverage consistent across rotating shifts and multiple care sites.

DIFFERENTIATORS

- **In-house workforce, no subcontracting.** Assignments are filled directly from the company's own staff, so multi-shift and short-notice coverage does not depend on outside agencies.
- **Full continuum from one provider.** Clinical care, daily personal support, staffing, and transportation come from a single organization, so buyers cover the entire care cycle without managing multiple vendors.
- **One relationship across three states.** Massachusetts, Rhode Island, and New Hampshire are served by one agency, simplifying administration for buyers operating in more than one location.
- **Established New England network.** A caregiver base and senior-care clientele developed over four years of continuous operation.
